February 19, 2021

**Meeting Called to Order:** The February 19, 2021 meeting of the Ex Comm was called to order at 9:04 a.m. by President Mark via WebEx.

## **Additions/Corrections/Approval of the agenda:**

- ✓ **MOTION:** Steve moved to approve the Agenda with no additional items. Marsha seconded the motion and it carried unanimously.

## **Flyer and Event Budget Approval**

- The budget for the Homosassa weekend was presented for approval. Estimated to sell 165 wristbands @\$20.00 each for an anticipated income of \$3,300.00. Expenses will include entertainment in the amount of \$1,600.00 and door prizes/stuffed monkeys in the amount of \$400.00. No funds were requested from the Club for this event.
- ✓ **MOTION:** Gypsy moved to accept the proposed budget as presented. Steve seconded the Motion and it carried unanimously.

## **Minutes of Previous Ex Comm Meeting – Gypsy Ginchereau**

- The Minutes of the January 15, 2021 Ex Comm Meeting were circulated to the Ex Comm Members electronically by Secretary Gypsy.

## **Financial Report – Treasurer Barb Beil:**

Treasurer Barb presented the Jan 2021 Financials.

- The Clubs beginning balance for January 2021 was \$24,202.00 with January income (deposits) of \$7,272 for a balance of \$31,474.00. Of that balance, operating expenses paid totaled \$2,401.99 for an ending balance of \$29,072.00
- ✓ **MOTION:** Marsha moved that the Jan 2021 Financial Report be accepted as presented subject to audit. Gypsy seconded the Motion and it carried unanimously.
- Barb circulated the Encumbered Funds Report.
- Except for 2, all Spring Training trip ticket costs have been refunded.
- Homosassa T-shirts refunds and Daytona tickets – have some unclaimed or “requests to donate” remaining funds. These funds need to be reallocated.
- ✓ **MOTION:** Gypsy moved to distribute those funds as follows: \$182.00 to general Charity and \$505 to Operations. Rob seconded the Motion and it carried unanimously.
