# THE VILLAGES PARROT HEADS EX COMM MEETING MINUTES February 17, 2023

### Flyer and Event Budget Approval and Other Guest Speakers:

- **2023 Poker Run Budget:** Kathi Purdy circulated the proposed budget for the Poker Run. The total amount requested from the club will be \$4,650.00 and includes \$1,600.00 for the banks.

#### **President's Report - Mark Woodland:**

If we rent all of the rooms at the Savannah Center we will have a max capacity of just under 400. Mark wants to have fundraisers to offset the cost of this event to the club.
