  - ✓ **MOTION:** Marsha moved that the April 2021 Financial Report be accepted as presented subject to audit. Rob seconded the Motion and it carried unanimously.

### President's Report:

 Blood Drives: Next blood drive will be held at Brownwood Hotel on May 31, 2021. Skip will talk to One Blood regarding possible pins for blood donors. September 11, 2021 Blood Drive – still not sure if it will be held at the Firehouse.
